

# International Public Notice: The Fundamentals

1. Most of the planet is impacted by what we call The Great Fraud and a British-Romano plan to create a monolithic system of Corporate Feudalism benefiting themselves at everyone else's expense.
2. This Fraud has resulted in everyone doing business almost exclusively in the unlikely jurisdiction of Maritime Commerce, and becoming subject to Maritime Commercial Law, which in the modern world is a Scottish variation of Roman Civil Law.
3. We are all now faced with a choice and the choice is this: we can break this British-Romano monopoly and take responsibility for running our own land and soil national government, or we can be ruled over by faceless unaccountable corporations in the business of providing government services.
4. Their "Plan" has already advanced to a point wherein interlocking trust directorates and their non-trust equivalents have established a "Mega Corporation". The existence of this thing was proven by Dutch computer analysts more than a decade ago and has since been further investigated. 5. The Perpetrators have created numerous schemes and excuses that they use to: (1) displace their tax burdens onto the living people; (2) tax their

employees for the "privilege" of working; (3) seize upon private property and unlawfully convert it into public trust property; (4) place these public trusts under the direction of their henchmen in the Bar Associations; (5) limit banking services and legal system options to their own Maritime Commercial Bank system and their own Scottish-Roman Civil Law "Justice" system thus forming a giant illegal monopolization of banking and judicial functions; (6) rat-holed enormous amounts of money in slush funds, especially pension funds, and together, monopolized the ownership interests in the world stock markets and exchanges.

6. We have thus far begun the dismantling of the Roman Municipal Trusts and claimed the Beneficial Ownership Interest in the Parent Corporations and all their franchises on behalf of the living people.

7. We have similarly claimed the Beneficial Ownership Interest in all the phony intestate British Seaman's Estates that have been named after each one of us and converted into Public Trusts, the State Trusts, and other Trusts that have been used to rat-hole and control resources belonging to us both individually and collectively, also on behalf of the living people.

8. Each one of us has an urgent need to reclaim their lawful birthright political status and to revive and restore their traditional national governments; the only alternative is to live as "farm animals" and allow these unaccountable, faceless, insubstantial corporations treat us like so many cows in a feedlot.

9. Klaus Schwab said it best from the Corporatist viewpoint only we need to hear it in the proper context: cows in feedlots own nothing and are "happy" right up until the moment they get shunted down a slaughterhouse chute. The only difference is that we are men and women with the capacity to discern evil--- and the ability to dissolve these corrupt and criminal corporations.

10. We can lawfully and responsibly run our own national government and our own affairs, but we must bravely wean ourselves from the corporate teat and the coercive programming they have used to promote the idea that we need them or are dependent on their services, when in fact, we are the

necessary element that they need to exist: their employers, underwriters, and ultimate owner/beneficiaries.

11. We, the actual Americans, have done the heavy lifting to expose all this in ways the General Public of all Nations can understand. We have created and processed the commercial and legal claims in favor of the living people and the actual countries that have been subourned by illegal and immoral British Territorial occupation and the establishment of the above-described foreign corporate governmental bureaucracy in each of the victim states.

These Fascists, for that is the political persuasion they belong to, have worked white collar crime schemes to create and establish this entire framework by working behind the scenes, using legal loopholes and claims of "national security interest" to cloak their illegal occupation of sovereign nations, also used semantic deceits, impersonation, and unlawful contracting procedures to attain their ends. Now, they are being dissolved -- literally and figuratively. The process of dismantling these criminal entities or placing them under new management is underway, but the real cat-fight has yet to come.

13. The Plan was always to sacrifice the Municipal Corporations to the Territorial Corporations, and split the difference, as usual, 60/40. This would leave the rest of us paying for everything, and the miscreants benefiting themselves at our expense either way. We have thrown big monkey-wrenches into this because we were not deceived by the illusion that there were two "sides" to this, and did not fall into the error of thinking there was a "bad" Municipal Corporation and a "good" Territorial Corporation. We recognize the living people as the Beneficial Interest Owners of both the Roman Municipal Corporations and the British Crown Corporations and have claimed all Beneficial Interest in both sets of corporations for the living people.

For example, the beneficial assets of FLORIDA, INC., a franchise of the UNITED STATES, INC., and Florida, Inc., a franchise of the Territorial "United States of America, Inc." are all owed to the living people of Florida.

13. It is well-past time for all the people in every country to wake up and unite in opposition to misuses and abuses of corporations; every politician who doesn't immediately answer the helm on this issue needs to be investigated for racketeering, blackmail, bribes, and other influences and criminal wrong-doing.

14. Our American Government vested in the people living in and being part of the population of the fifty American States, is not an incorporated entity and is the mutual interest instrumentality of the sovereign states and people of this country. As such we represent the Beneficial Interest Owners of both the Municipal Corporations and the British Territorial Corporations involved in this massive fraud.

We have claimed back all the purloined assets and credit, all Beneficial Ownership Interest, on behalf of the living people and sovereign nations who have unwittingly paid for all of this corporate malfeasance and crime.

15. We do not accept the False Offer being made by the Territorial Corporations to collect our interest in the Municipal Corporations "for" us; the Municipal Corporations were constructed on the false presumption of a British Territorial Seaman's Estate and State Trust interests, and we are owed all Beneficial Ownership Interest in those legal fictions, too. A single two-part action is required --- the recoupment of the Municipal Corporation assets for the benefit of the living people and sovereign nations; and the return of all Beneficial Ownership Interest in the Territorial Corporations involved in this gigantic Fraud Scheme, too.
