Please be informed that the United States is in interregnum; its Constitution of 1789

The upcoming Presidential elections in the United States cannot result in a legitimate regime  
as the electoral college will not be duly constituted.

This state of affairs is public, and a coalition for the rule of law on the Board of Governors of  
the World Bank and International Monetary Fund that administers the nations' international  
monetary gold reserves pursuant to the Bilateral Minesfield Breakthrough Successor
