

International Public Notice: Real Jews Can Count

One of the Great Debates still raging in the world is the question, "Can God change?"

The Bible is a potent focus for apparent controversy, on one hand, we are told that God is the same, yesterday, today and tomorrow. On the other hand, we are given instances, like the decision to destroy the world with a giant flood, where it appears that God "regretted" decisions and actions taken in the past, and changed course accordingly.

Nowhere does this question become more important than in the debate that surrounds overturning the Old Testament standard of "an eye for an eye and a tooth for a tooth" in favor of the Christian ideal of "turning the other cheek".

These radically opposed standards of justice and behavior are at the heart of the cultural, religious and social struggle in the Middle East, where scholars not only debate this question, but live their lives according to their conclusions.

The Arab world pretty much agrees with the Old Testament standard; you cause me no harm, I cause you no harm. Cross the line, and I will inflict the same damage on you that you inflict on me. It is a reasonable standard for justice, though we all realize that sometimes it is better to bypass it in favor of mercy.

When Saladin entered Jerusalem, for example, he had every right to kill everyone in the city according to the Old Testament Law. Instead, he ordered the city to be cleansed and for peace to be established.

The old standard of an eye for an eye and a tooth for a tooth does not prohibit or preclude mercy. It simply sets a standard for justice. The loss of an eye is not repaid by the loss of a tooth. Neither is the loss of one eye repaid by the loss of two eyes.

Under Old Testament Law, everything is kept in balance. The Law of Kinds is honored -- eyes for eyes, teeth for teeth. The Law of Balance is honored -- one eye for one eye, one tooth for one tooth.

The Old Testament Law, followed by both Jews and Arabs, has the added benefit of being simple to understand and enjoys the recognition that it is fair overall.

Critics complain, for example, that there is no requirement that the victim of a crime must forgive an offense or loss, regardless of the age or mental state of the offender. Proponents argue that the loss or injury for the victim is the same, so the punishment should be the same.

There is a divine balancing act between exact justice and mercy, which, when we successfully navigate it, we recognize as true justice.

The problem of Benjamin Netanyahu for Jews and Arabs and everyone else, is that the man can't count and doesn't abide by any law, including the Old Testament Law.

Hamas kills 1,100 and in response, Netanyahu kills over 50,000 -- plus razing the infrastructure of the Gaza Strip.

The Old Testament Law says, you kill 1,100 of my people, and, more or less a few by mistake, I kill 1,100 of your people. We call it even.

In this way, the damage is limited, the outcomes are fair -- even if they are terrible, and hopefully, lessons are learned.

There is nothing in this current situation that would allow carpet-bombing Gaza as a lawful response.

There is no justification or Law in this world or the next that Benjamin Netanyahu can appeal to for his actions. Neither logic nor mercy will uphold him.

He is a Jew, purportedly, who doesn't know -- or who chooses not to obey -- his own Law.

Numerous voices have been raised this past week as the news circulates through diplomatic circles that the actual American Government does not support Israel and that we are leaning on Donald Trump harder than AIPAC.

Why is this so scandalously noteworthy? Nobody in a sane world supports genocide. Nobody aligned with justice supports genocide. Nobody but corrupt politicians would ever stand by in meek silence.

And nobody but a man blinded by prejudice or by profit would do what Donald Trump has done -- give \$16 Billion to Israel, which is in the middle of committing absolute genocide, during his first 40 days in office.

We are aware that Israel is surrounded by 22 Arab countries that hate its guts and would like nothing better than to see it disappear from the face of the Earth. That does not excuse willful genocide.

We are aware that the followers of Judaism feel a deep religious and cultural attachment to this little piece of Earth and that they earnestly believe that the Creator of the Universe gave it to them. That does not excuse willful genocide in Gaza, either.

Real Arabs and real Jews are both Semitic peoples, both ultimately come from the same Father, Abraham. They are half-brothers. One branch descended from Hagar, whom the True God comforted in the wilderness -- twice; the other branch descended from Sarah, whose unreasoning jealousy spawned the first injuries between them.

Both are bound by the same Law.

We are aware that there is no lack of land in the Middle East. We are aware that the 22 Arab nations have made a sacrifice of Palestine and Palestinians in a very cynical way, by refusing to give the Palestinian people any permanent refuge among the Arab nations and using them as a spearhead to prod Israel.

It's their embarrassment -- which we provoked -- that has led to the recent (rejected by Trump) offer to form an Arab-backed coalition to rebuild the Gaza Strip and heal its people.

Obviously, in view of Trump's refusal of the Arab proposal, the whole point for Trump and Netanyahu is to clear the Gaza Strip for new development, and though 5-star hotels and casinos may have a part in that development, that's not what is driving it.

What is driving this genocide and "permanent" desolation of the Gaza Strip, is development of the Eastern Mediterranean Oil Basin and a new "Eastern Sinai" Canal to rival the Suez Canal. It's Big Money driving this opportunistic action by Netanyahu. Oil Money. Marine Transport Money. Monopoly Interest Money.

The real Drivers behind this genocide in Gaza could easily afford to buy land in the Middle East and develop it as a new homeland for the Gaza refugees, but as long as they hide in the shadows they can avoid the expense of their avaricious destruction of homes and lives.

So we are calling them all out.

We know who you are. We see you.

Trump, Bibi, Et Alia ----you want this little strip of land so bad, that you kill 50,000 innocent people and destroy their homes and schools and hospitals, their roads and water wells and sanitation facilities and electric plants?

You carpet bomb Gaza worse than Dresden in WWII? And you think that nobody is watching and nobody cares? You think you are going to skate away and blow some fairy dust up our rumps? Tsk, tsk, just move along, there's nothing to see here?

Not likely.

Looks like that \$16B that Trump gave Netanyahu was drawn off of our credit; it more or less had to be, because in truth, Mr. Trump is running a government services corporation that has never made bank in its entire history, and has been used for bankruptcy fraud purposes for the past 160 years.

The British Crown Corp is feeding the USA, Inc. just barely enough money to keep it solvent and hoping that they succeed in their False Claim to be the ultimate Receiver in bankruptcy of the Municipal UNITED STATES Corporation.

They aren't the ultimate Receivers, but they are trying hard to play a two-fisted game in a three-fisted arena.

All three (3) Public Trusts have to be dissolved.

The "intestate" American Infant Decedent Estates that were purportedly waived on behalf of infants in their cradles -- without the nicety of disclosure to the Mothers or later disclosure making these foreign citizenship contracts conscionable to the victims.

The "intestate" Seaman's Estates subsequently established on behalf of non-existent British Merchant Mariners operated in "in our names" -- which were purloined and copyrighted by the British Crown Corp as a result of the aforementioned undisclosed, illegal and immoral registration of American babies as British Territorial U.S. Citizens.

The "intestate" Roman Inferior Municipal trusts set up as Cestui Que Vie trusts also "in our names" for the benefit of "citizens of the United States" presumed to exist and to voluntarily accept this foreign political status.

The whole enchilada has to be returned to the living people to whom all these assets and beneficial interests belong, and to the administration of their lawful governments.

There should be no question in the minds of any service member or United Nations Trustee what services The Constitution of the United States of America stipulates --- and doesn't stipulate.

We are here, the American Government, in Session, competent and able to represent itself in all international affairs.

Mr. Trump will have to be content.

The Oil Barons and Shipping Magnates and Bankers who are ultimately responsible for the destruction of Gaza are responsible for the cost of relocating the survivors, rebuilding all their infrastructure plus improvements, and for turning this new Oasis into a beautiful environment; in addition, they are responsible for the safety and security of this new bought-and-paid for Palestinian state, wherever it will be established.

They are also under obligation to provide education, employment and business opportunities, and a Gaza Fund to provide individual medical care, pensions, and a very substantial re-investment fund to provide an ongoing share in the profits the Perps realize from their self-interested, immoral, and illegal destruction of the Gaza Strip.

They may not like it, but that's what they owe, at a minimum, to the living people they have harmed. They can never pay their debt to those who have been murdered.

The Arab States are responsible for finding a decent chunk of land and selling it for a reasonable and customary price for the establishment of a Palestinian homeland among the Muslim nations.

Netanyahu has established a 1:50 ratio and burnt Earth policy that more than justifies the obliteration of Israel by 22 Arab countries--- under their own Old Testament Law.

The Israelis who claim to be Jews need to seriously reflect upon their responsibility for promoting Netanyahu and his murderous regime -- and contemplate the fact that from now on, the consequences of any war-mongering and profiteering will come home to them, not to us.

Mr. Trump doesn't have our permission to spend a penny of our credit on any more offensive armaments or slush funding for Israel or any phony Terrorist organizations --- not ever again, no Isis, no Hamas, no any-other-ginned up and foreign-financed CIA/MI6 organizations whatsoever.

It is firmly against the National Policy of Mr. Trump's employers to meddle in any internal affairs of any other nation. We never approved the so-called Monroe Doctrine, which has existed for lack of explicit rebuttal. Here is the explicit rebuttal.

The banks are on Notice: the British Crown needs to spend its own money on its own squalid and violent activities from now on.

Americans may work for these foreign corporations, but they are foreign corporations nonetheless, and their internal operations and corporate policies have little or nothing to do with us.

Less than 8% of all Federal "laws" potentially pertain to Americans, and then only when Americans knowingly and voluntarily engage in federally regulated activities, or enter property set aside for federal use. Period.

Our contracts to receive services from these foreign subcontractors are public documents fully expressed as The Constitution of the United States of America and The Constitution of the United States.

There is no other accommodation express or implied, no Emergency Powers, no excuse for substituting their officers for our elected officials, no excuse for substituting their private political elections for our public elections.

There is no reason for their illegal and immoral practice of mis-identifying and falsely registering American babies born in the States of the Union as Territorial U.S. Citizens, nor any subsequent reason for the creation of individual Municipal estate trusts alleging any public interest in private assets.

These activities are crimes explicitly recognized as capital crimes under both the Hague and Geneva Conventions. These actions have no possible standing among military or civilian populations nor under any form of law that this country and its people have ever practiced or condoned.

There is no legal or lawful occupation of this country by Mercenary Forces allowed or allowable; there is no application of the Law of War and no protection for the Perpetrators under the Hague Conventions available.

Abraham Lincoln deceitfully and immorally and unlawfully converted our national military into a commercial mercenary force. He did this under color of law, without granted authority, without public disclosure, and in gross breach of trust. The military services owed to this country must be lawfully converted and must return to their lawful service and lawful service obligations without delay.
