## International Public Notice: Reply to International Court of Justice and Chief Fast Horse Questions

Let us begin with the issue of names applied to groups of people who have similar customs and language and culture which we call nations.

As an example, it has been the custom in this country to refer to Chief Fast Horse's nation (tribe) as the "Lakota Sioux", or, often, just "the Lakota" or "Sioux". So we have three different names being used to refer to the same people.

The same exact thing happens when we refer to the people inhabiting a defined geographical space "having similar customs and language and culture" as, for example, "Texans" or "Minnesotans" or "New Yorkers". This is what we are talking about when we discuss "nation-states".

What happens when you have two (2) distinct groups of people being called by exceedingly similar names? Then there are likely to be confusions, especially when, when spoken verbally, they sound exactly the same:

"The United States of America" sounds the same as "the United States of America", but one is an American unincorporated Nation and the other is a British Territorial Commercial Corporation.

We don't blame the International Court of Justice or Chief Fast Horse for being confused. This is exactly the deceit used to commandeer our government and misrepresent the American Government for sixteen decades. It's called a "similar names deceit" and is a confidence racket that leads to the crimes of aggravated identity theft, credit theft, impersonation, and barratry ---- all of which we have suffered as an entire country.

The Chief has asked, "When, where, why, did I lose my land to these immigrants? How else did they acquire land and from whom --- other than by genocide?"

We ask, "Who, exactly, committed genocide against your people?"

And the answer is "the United States of America" Incorporated --- a British Territorial Commercial Corporation, not the American Government, "The United States of America" Unincorporated.

In every case we have been able to find, the Native Nations were attacked and defrauded and abused by the British Territorial version of "the United States of America" Incorporated and by the British Monarchy defaulting on Treaties.

Our American version of The United States of America -- Unincorporated -- extended full rights to the Native peoples and they have been Dual Nationals since the Founding. To this day, every Winnebago born in Wisconsin is both a member of the Ho-Chunka Nation and a Wisconsinite, and we have gotten along with that understanding just fine.

If you stop for a moment you will realize that this is how the Cherokee and Seminoles and Choctaw and Creek and many other tribes in the Southern and Southeastern United States were able to live at peace and have homes and farms and everything else, like any other American --- right up until Andrew Jackson took over the United States of America, **Incorporated**, and the "Blue Coats" came into being, along with The Trail of Tears, and after that, the Reservations, and Residential Schools and all the rest.

If you think about it, it was the protective and friendly American Government and their policy of including the Native people as Dual Nationals that made it possible for the Cherokee and Seminoles and other Native Nations to establish such extensive farms and plantations and have schools and do all the things they did prior to Andrew Jackson.

The American Government can't be accused of acquiring land by genocide. We did it the old fashioned way by eight long years of fully declared war against the British Empire, which had established treaties and paid money and practiced genocide and done a lot of other unscrupulous things for two hundred years prior to The War of Independence---- which our government fought and won for all Americans including the Native Nations, forevermore.

The real defeat of the Native Nations in War came prior to our fight with the British Empire during the previous so-called "French and Indian War" (1754-1763) that took place prior to The War of Independence (1776-1783).

The French and their Native Nation allies fought the British Empire for nine years and lost; the American Government fought them for eight years more and finally won it all back from the British Empire.

So, in answer to Chief Fast Horse's question --- the Native Nations lost land via warfare and basically all known native claims as well as all French claims were extinguished by the French and Indian War which also included settlement in Canada.

To assist everyone in sorting through the "similar names deceit" practiced upon us by the British, we are attaching a one-page graphic illustration that separates the American Government which is all unincorporated and the "United States" Government which was and is all incorporated.

The American States and their population, our nation-states, are defined in exactly the same way as the Lakota nation, with one important difference. The land interest apportioned to the nation-states are defined within known and agreed upon geographical borders, which is a requirement of international law, whereas the Lakota nation claims range all over this country and Canada, with loose ever-varying territory, depending on time of year, and agreements among various bands of various tribes.

These territorial borders were always in dispute and subject to sudden change. When the first white settlers arrived in Wisconsin for example, there were frequent Lakota raids against their cousins, the Woodland Winnebagos, and many bloody battles over seasonal hunting grounds were fought, with both tribes claiming rights of various kinds.

This lack of settled borders led to more or less constant warfare even among tribes that were otherwise friendly and within the same language groups. This finally ended when the nation-states established settled borders and included all the Native Nations.

This is why the Native Nations, among other practical reasons of law and administration, must accept the fact that Europeans who settled in this country generations ago "are people, too".

U.S. Citizens and Municipal "citizens of the United States" function as <u>persons</u>, but all the rest of us are <u>people</u> and the <u>people</u> here fully recognized the <u>people</u> of the Native Nations more than two centuries ago.

It was the European Monarchs and European Commercial Corporations and European Municipal Corporations that did the dirt to us all, so what has to be corrected is the right of the living people to the land and soil. There are no quarrels on our American Government's part, now or ever, that Native <u>people</u> are <u>people</u> and have all the same rights as any other American, which we won by honorable warfare against the British Empire.

Please see the attached one-page graphic illustration that shows how our unincorporated American Government organization is mirrored by the incorporated United States Government that was supposed to operate under delegated powers and provide "good faith service" to us all.

Donald Trump is the "President" of the British Territorial "United States of America" ----Incorporated.


He is not the President of The United States of America --- Unincorporated.
