

International Public Notice: Venal Redefinitions and Other Abuses

Everything has its genesis from something else in our Universe, from the instantaneous point we call "Source" to the final jot of existence, so that the question, "Which came first, the chicken or the egg?" really begs the question --- "Where did the chicken or the egg, either one, come from?"

What mysterious force has resulted in their appearance, their profound ordering of substance within themselves, and the immense amounts of energy required to create and build that order, maintain it, and then, to release it, back to whence it has come?

So it is when we embark on a study of law, which leads to a study of religion, and then to the history of religion, that finally reveals so much about where concepts of "government" come from.

You have probably heard mention of "the Rule of Law", and wondered --- if you've been following along --- what's a Rule compared to a Law? What does "Rule of Law" mean?

More fast ones and substitutions?

Yes, as it turns out.

The use of Rules comes from early Church Orders, primarily Augustinian and Benedictine, that were established as the foundational principles and purposes of these Orders. These Rules were supposed to apply to all members of the Order,

both priests and lay members, and provided a definition of purpose and agreement that all were expected to know and abide by.

The combination of the two concepts, "Rule" and "Law" in "Rule of Law" is therefore, as we have so often seen in other settings, oxymoronic.

A Rule is not a Law and a Law is not a Rule, and they are in fact mutually exclusive; a rule is voluntarily accepted by individuals according to their values, conscience, and beliefs, whereas a law is externally imposed under force without regard for personal conscience, values, or beliefs.

Elevating Law to the level of a Rule suggests the slave-like subservience of the individual conscience to whatever external authority or government is generating whatever form of "Law".

It does in fact imply the loss of an individual conscience or will.

Let's give an example --- the issue of abortion on demand.

For a number of years, this was "the Law" externally imposed; the exercise of the Law, however, was left to the Rule of individual conscience.

All this sudden talk about "the Rule of Law" and its implications has therefore sparked considerable consternation, wonder, and debate.

It suggests the existence of individuals either naturally not having a conscience or will, or the creation of a population of subhumans deprived of their right to exercise their conscience and freewill: slaves.

Certainly, robots have only an artificial conscience or will dependent on the decisions and values of their programmers, and a system of law pertaining to the operations and programming of robots might be described as the Rule of Law, simply because they have no independent will or conscience.

The second, more sinister meaning could be reference to a system of law applied to people arbitrarily defined as "subhuman" --- or as the case actually is, "transhumans".

The U.S. Supreme Court case, *Biden v Missouri*, revealed the intent of the vaccine patent holders to claim that the people who received the mRNA jab have been

turned into Genetically Modified Organisms (GMOs) and are now owned by the patent holders and redefined as "transhumans" having no natural and unalienable rights and no Human Rights, either.

This repugnant claim was supported by the U.S. Supreme Court and is most likely the reason that the attorneys are babbling gobbledygook about the Rule of Law; it would apply to these Transhumans as they would be slaves and have no ability to express their freewill or conscience.

We suggest that it is more than past time to dissolve all these offending corporations and put the attorneys permanently out of business.

Foreseeing this venal agenda, our State Assemblies came together and passed our first Public Law in over a hundred years, forbidding the exercise of any such claims against living people on our land and soil.

We have also moved swiftly to overturn earlier such attempts to self-interestedly "redefine" us as British Subjects and U.S. Citizens, and from there, to confer the crippling "citizen of the United States" status on us, without our knowledge or consent and without our agreement.

All these horrific and criminal activities have hinged on arbitrarily redefining living people as something "else" --- humans, subjects, and now, transhumans, using illegal, undisclosed, unconscionable, and implied contracts, and then enforcing this gobbledygook using corrupt courts and foreign systems of law.

Reducing a man to a "human" and then to a "transhuman" -- aka, "subhuman" is no different from what the Nazis did to the Jews.

It is just as repugnant, just as immoral, illegal, and unlawful, only it is being applied in a wholesale and indiscriminate fashion by commercial corporations engaged in crimes of state.

It has been our observation that the Roman Church has been deeply infiltrated by immoral influences and evil men who have used the Church as a "storefront" and cover for their heinous activities. The same phenomenon has beset the leadership structures of other religions, too. This has led to a broad spectrum failure of nearly all religious faiths and institutions to oppose the burgeoning evil in our midst.

Many people have wondered about the misuse and abuse of our public hospitals and the weaponization of medicine to promote mass genocide. We have pointed out on numerous occasions that medical doctors, nurses, dentists, and other medical professionals and even hair stylists who accept a "license" to serve federal citizens or to work in facilities receiving federal funding, are defined as "Uniformed Officers" under Federal Code Titles 8, 11, and 31, and not only can such officers be conscripted against their will into the military, but are also deemed to be part of an unseen "civilian military".

Hospitals, according to the admitted history and records of the Order, have been militarized since 1099, twelve years after the death of William the Conqueror.

Hospitals were first created to serve the sick, wounded, and dying soldiers of the Church during the Crusades, and though they have become public institutions funded by public money, their basic nature and character as military organizations has not changed.

The actual name of the Order is: The Military Religious Order of the Hospital of St. John of Jerusalem.
