Thankyou for not answering my letter dated 14 September 1998.

The prophecy of Queen Elizabeth I, and indeed my very prophetic letter to Queen Elizabeth II dated 12 March 1996 all coming true (see p2 of that letter) i.e.:-

[&]quot;...the <u>King of Scotland</u> would become <u>one day</u> King of Great Britain".

It therefore appears that God has confirmed in Law my "Divine Right" to rule the Kingdom. I have enclosed a copy of that final order to remind Your Majesty of what it stated. As a Lawful Court Order, it must be obeyed.

According to Black's Law Dictionary the word "Sovereignty" means :-

"The <u>supreme</u>, <u>absolute</u>, and <u>uncontrollable power</u> by which any independant state is governed; <u>supreme political authority</u>; <u>paramount control of the constitution and frame of government and its administration</u>; the <u>selfsufficient source</u> of political power, from which all specific political powers are derived; the <u>international independence of a state</u>, combined with the <u>right and power</u> of regulating its internal affairs <u>without foreign dictation</u> (SUCH AS THE EUROPEAN UNION); also a political society, or state, which is <u>sovereign and independent</u>.

The power to do everything in a state without accountability, - to make laws, to execute and to apply them...."

None of the above criteria in the definition of "sovereignty" can be attributed to Your Majesty, for it appears the British Parliament has taken those specific qualities which make a true Sovereign from the Crown. They may be attributed to me, for I have done more to establish those <u>rights</u> than anyone in the Realm. Your Majesty is therefore by definition <u>not a Sovereign at all - a quasi-Sovereign -</u> a contradiction in Law. It is therefore

not logical for any normal minded person to contemplate the usefulness of such a person in Law - for there appears to be no earthly reason for such a person to exist - except to be manipulated for political expediency. It is therefore, by all common sense, logic, and reason, not possible to believe or hold allegiance to such a person. William Blackstone stated in his "Commentaries on the Laws of England", Bk.1, Section 3, titled "Of the Laws of England", at p70:-

"....that the law (I.E. THE SOVEREIGN) is the <u>perfection of reafon</u>, that it <u>always</u> intends to conform thereto, and <u>that what is not reafon is not law</u>."

It therefore appears that Your Majesty loses on all counts i.e by logic, common sense, reason, and law.

"REX NON DEBIT ESSE SUB HOMINE, SED SUB DEO ET SUT LEGE, QUIA LEX FACIT REGEM. Bract. fol.5. The king ought to be <u>under no man</u>, but <u>under God and the law</u>, because <u>the law makes a king</u> (AS IN MY CASE - NOT YOUR MAJESTY'S) Broom, Max. 47.".

It appears there's no one in charge of the Kingdom, and hasn't been for a long, long time - the reason for the rise of crime in the Realm - it appears Your Majesty fails on that account as well.

Your Majesty had better start understanding the Law, rather than listen to political advisers, for Your Majesty is about to not only lose the Kingdom (to the European Union), but also what little authority You have left.
